# What are GDL Programs?

Graduated Driver Licensing (GDL) programs are designed to minimize the highest risk situations for a new driver while they safely gain crucial experience behind the wheel. GDL programs introduce young drivers to the road slowly with a gradual, staged approach to earning a driver license

Since the inception of GDL laws, teen fatalities and serious injuries have been reduced by up to 40%.

# GRADUATED DRIVER LICENSING LAWS

Ohio









STAGE 1

## **INSTRUCTION PERMIT**

The Instruction Permit stage is the time to gain driving experience.

This stage can begin at age 15½. Once a teen has studied the state's Driver Handbook, they should head to the Bureau of Motor Vehicles (BMV) to take the written driver exam. Once they pass the exam, they become the proud holder of an Instruction Permit. Then, they need to enroll in driver's education at a licensed driver training school.

Teens need a minimum of 50 hours of behind-the-wheel supervised driving time with a licensed parent or guardian. Ten of those hours must be at night. They will hold their Instruction Permit for a minimum of six months before taking the BMV driving test for a Probationary License.

STAGE 2

## **PROBATIONARY LICENSE**

Once a teen passes the behind-thewheel driving test at the BMV, they will receive their Probationary License. A Probationary License allows the teen driver to drive ALONE. However, they must follow these driving restrictions while in the ProbationaryLicense stage:

- No passengers, with the exception of one non-family member, for the first year unless accompanied by a parent or quardian
- No driving between 12 a.m. and 6 a.m. during the first year or between 1 a.m. and 5 a.m. after the first year and before turning 18 unless accompanied by a parent or quardian
- Seat belts are mandatory for all people in the car
- No electronic device use while driving hands-free or not

Teens will have a Probationary License until they turn 18.





STAGE 3

### **FULL DRIVER LICENSE**

After one year of safe driving experience, the *passenger* GDL restriction is lifted. When you turn 18 years of age, the *nighttime* and *electronic device* restrictions are lifted. Remember hands-free is not distraction-free. *Seat belts* remain mandatory for the driver and the front passenger of a vehicle under Ohio law.

With full driver license privileges, teens can participate in all of the privileges, responsibilities, and enjoyments that come with driving. But remember, driving is a privilege, not a right, and it is important to drive safely at all times no matter your age or experience.
